# Training

## Highlights, New Programs, and Certifications

The total training hours that Dallas Police Department Officers completed in the calendar year of 2021 are 1,720 hours. These hours are a combination of State Mandated In-Service hours, specialized schools, and safety classes. As the Town of Dallas continues to grow, we as officers are consistently growing as well through the aid of more training offered by the State of North Carolina and other certified facilities. Through this knowledge, we will continue to effectively and professionally do the very best for our citizens and the Town of Dallas.

At the end of 2021, the Dallas Police Department had a staff of 15 sworn full time employees, 2 non-sworn, and 1 part-time sworn employee. Within the 16 sworn employees, we currently have (5) that are Certified Field Training Officers, (4) that are Certified Field Training Supervisors, (2) that are Certified in Advanced Roadside Impaired Driving Enforcement, (2)

that are K-9 Certified, (6) that are Radar Operator Certified, (1) that is Certified in Vehicle Reconstruction, (1) that is a General Instructor, (3) that are Certified Stop Stick Operators, (5) that are Certified in Less Lethal, (15) that are Certified in Oleoresin Capsicum (OC) Spray, (9) that are Certified in Baton, (16) that are Taser Certified, (8) that are Intoximeter Certified, and (12) that are certified in Standardized Field Sobriety Testing (SFST). All sworn officers also completed training to use and operate the (6) Alco-Sensors units the department has.

# Monthly Case Review Highlights

Please note that this is a few case reviews with highlights. These are not all of the reports and or incidents reported and investigated.

Officers responded to a missing persons call for a juvenile where they spoke to the mother. The mother advised the juvenile lied and said she was waiting on her aunt to pick her up. The mother called the aunt and determined the juvenile was lying. When the mother arrived home, the juvenile was not there. The juvenile was then entered into NCIC as a missing person. After investigating, detectives and officers were able to determine who the juvenile was with and their location. When officers arrived, they located the male subject that the female juvenile was with and brought them back to the police department for an interview; the female juvenile was no longer with him. While interviewing the subject, he admitted to several various crimes within our jurisdiction. The male subject was then arrested and transported to the jail and served multiple warrants including Contributing to the Delinquency of a minor and Statutory Rape. Later in the day, the female juvenile was located and transported to Caromont Regional Hospital to be checked out before she was released to her mother.

While watching a house where the resident had a warrant, and the department has received many drug complaints, a vehicle pulled into the driveway then another vehicle pulled into the driveway shortly after. The officer then watched as a male subject exited the second vehicle and approach the first vehicle. After about a minute, the male subject returned back to the second vehicle and left the area. Officers then decide to approach the residence and noticed that the first vehicle was occupied and still running. When the driver was asked, he advised that he or his girlfriend did not live at the residence. Officers then asked if he had illegal drugs in the vehicle, and he stated "no". The driver then became agitated and advised the police that he would not give them consent to search the vehicle because the vehicle was not his. Officers observed a knife in a sheath above the driver's head strapped to the sun visor. The driver then became agitated and began screaming at officers, so they ordered the driver out of the vehicle based on his aggression toward law enforcement. After several minutes, the driver complied and exited the vehicle. After stepping out of the vehicle, the officer conducted a pat down of the subject and felt what appeared to be a needle in his jacket pocket and a baggie in his right pocket containing a hard substance. Based on the officer's experience, the officer believed that a controlled substance may be in the needle and the baggie that was located in the pocket of the subject. The baggie contained a white in color crystal substance that appeared to be consistent with methamphetamine. Officers also found a large amount of cash on the

driver. The white crystal substance weighed 13.2 grams. Based on the amount of methamphetamine, the cash, and a separate container inside the vehicle that the officers also found that contained a white crystal residue, the driver was arrested for Intent to Sell and Deliver Schedule II and Possession of Paraphernalia. The officers then put the cash and drugs into evidence for the drugs to be sent off to the lab. Officers were unable to make contact with anyone inside the residence.

Officer was conducting routine patrol and was behind a vehicle. The officer observed the vehicle drift halfway across the double yellow line. The driver jerked the vehicle back into his lane and continued to weave within his lane. The driver again crossed the center line, jerked the vehicle back, and started to speed up. Officer activated his blue lights and initiated a traffic stop. As the officer was approaching the vehicle, he detected a strong odor of Marijuana. As the officer informed the driver of the reason for the stop, the driver was visibly shaking and frantically reaching around the vehicle. The driver asked the officer if he could "just go home". After asking the driver where he was coming from and where he was going, the officer determined that his story was not adding up. As an additional officer arrived on scene, the initiating officer conducted a search of the vehicle and under the driver's seat recovered a large bag that had 30 grams of Marijuana inside. He also recovered a Marijuana cigarette in addition to a scale. The officer took the subject into custody and transported them to the Gaston County Jail. When the driver went before the Magistrate, it was determined they had seven pending charges and was already out on a \$10,000.00 bond. The Magistrate gave the driver a \$20,000.00 secure bond.

Officer was conducting stationary observation when he observed a vehicle beginning to approach his patrol vehicle and slow down. As the vehicle passed the marked patrol vehicle, the officer observed that the passenger was lying back in the seat as if he were attempting to hide. When the officer ran the plate, it did not come back to the vehicle it was displayed on. Officer then performed a traffic stop on the vehicle. As the officer approached the vehicle to advise the driver of the reasoning for the stop, the driver and passenger were talking to each other as if to distract the officer and would not sit still. The officer performed routine records checks and was advised by County dispatch that the license plate on the vehicle was reported stolen. The officer approached the passenger side of the vehicle where the owner was sitting and asked him to step out of the vehicle. As an additional officer was arriving on scene, the initiating officer gave a second command for the passenger to step out of the vehicle which he did and was taken into custody. The initiating officer has had several interactions with the passenger and almost all of these involved some type of illegal narcotic or paraphernalia. Officers were given permission to search the vehicle and recovered a silver spoon with what appeared to be Heroin residue on it in the passenger floorboard. In the center console, the initiating officer located ten needles that are regularly used for IV drug use. A black box was



discovered under the driver's seat containing a small bag of Heroin, an electronic scale, and several other small baggies were located inside. A bookbag was discovered in the back seat that either occupant could have easily accessed. 41 grams of Methamphetamine was recovered inside the bookbag. Both occupants were transported to the Gaston County Jail. Both subjects waived their Miranda Rights and spoke with the initiating officer and stated that the narcotics belonged to the other person. As the officer was completing his paperwork for the Magistrate, he was informed by a member of the jail staff that the passenger of the vehicle was seen dropping a needle in the floor while sitting on the bench. The passenger received a \$50,000 secure bond, and the driver received a \$75,000 secure bond. The stolen license plate was returned to its rightful owner.

Officer conducted a traffic stop after observing a vehicle that did not have a registration plate. As officer proceeded to stop the vehicle, he observed the driver looking in his mirror and started reaching toward the floor board of his vehicle. After several attempts, the driver finally came to a stop in the middle of the road. As the officer was approaching the passenger side of the vehicle to advise the reason for the stop, the driver rolled down his window approximately half way, and the officer immediately smelled a strong odor of marijuana coming from inside of the vehicle. As another officer arrived on the scene, the initiating officer was obtaining the drivers information and ran a records check. The driver of the vehicle was placed on the side of the curb while officers searched a black bag that was located inside the vehicle. The initiating officer located 43 grams of marijuana, scales, 12 grams of cocaine, and 8.5 dosages of Oxycodone. He also located an assortment of money that was organized in sections. At this time, the driver was placed under arrest and transported to the Gaston County jail and was given a \$25,000 secured bond.

Officers received a call for a vehicle crash with injuries. Officers immediately responded and located a vehicle with the left front wheel on the curb. When officers arrived, the driver was speaking with EMS. The driver would have to be asked a question several times then was making no sense when answering the question. Officers did make out that the driver said he was going to pick up his children. The driver was unable to stand unassisted and almost fell over. The driver's speech was slurred and had glassy eyes. One officer observed a handgun in the vehicle and removed it. While the driver was being checked out by EMS, the officer made the decision that the driver would be arrested for Driving While Impaired and No Insurance. Officers also found other drugs and narcotics in the driver's possession. Officers obtained a criminal history at the jail and discovered that the driver was a convicted felon. The driver was charged with Possession of Cocaine, Possession of Schedule I, Possession of Firearm by Felon, Driving While Impaired, operating a Vehicle with no Insurance, Possession of Marijuana Paraphernalia, Possession of Drug Paraphernalia, and Possession of Schedule VI and was transported to the Jail.

Officers were dispatched to a vehicle crash where the vehicle was rolled over and someone was trapped inside of the vehicle. When police arrived, EMS and Fire were attempting to get the trapped subjects out of the vehicle. EMS and Fire were able to get one subject out of the vehicle. The other subject in the vehicle was deceased.

Officers were dispatched to a location where an armed robbery just occurred. Upon arrival, officers met with employees that were standing by outside waiting for the police. An employee advised he locked the front door and went to the restroom while his coworker was stocking the coolers. The employee that came out of the restroom heard the suspect knocking on the door and motioned for him to let him in. The employee then unlocked the door and allowed the subject in the store. The employee said he then saw a silver handgun at this point, and the subject was telling him to give him the money. The employee then walked behind the counter while the subject stayed on the other side pointing a gun at the employee. The employee emptied the cash register and placed all the cash on the counter for the suspect. The subject gathered all the money and left the store on foot, possibly going behind the building and then across the street. K9 officer arrived and deployed his K9 partner. They were unable to locate the suspect and called the track off. Employees provided statements, and the scene was processed for prints. After investigation, detectives and officers discovered that one of the employees was involved in the armed robbery with a friend and warrants were obtained on both the employee and the suspects and they were later arrested.

Officers received a report of another agency pursuing a vehicle that intentionally tried to strike one of their police vehicles, and the suspected vehicle was traveling toward Dallas. The vehicle also had heavy damage from striking other vehicles. One officer stated that he heard gunshots as the suspect's vehicle approached the intersection and that he could see a female subject hanging out of the window. Officers then pulled out behind the two deputies and the suspect vehicle after they passed by, heading south towards the Dallas city limits. Officers pursued the vehicle, at one point going speeds of 70-mph in a 45-mph zone. While pursuing the suspect vehicle, the driver reached out of the window and fired shots towards officers but kept going. Later, the driver slowed down and reached out of the driver's window, firing shots at officers once again but still continued to flee from officers. A little later, the driver was all over the roadway and started slowing down as he fired shots and stopped the vehicle. The driver then exited the vehicle while firing at officers. Officers positioned their vehicles and returned gunfire. After learning the driver fled from the vehicle and ran, officers approached the vehicle and saw the passenger in the vehicle. The passenger raised their hands from the floorboard of the vehicle and was removed from the vehicle and detained. The female was moved to a

safe location accessed for any injuries or weapons. Other agencies, SWAT, and ERT teams came together in an attempt to locate the suspect driver that ran. K9 located the suspect's shoes, a high capacity 9mm magazine, and a shirt. The K9 then located the suspect in a small abandoned shed that was falling in. The suspect was then apprehended and arrested by another agency for Attempted Murder of Officers and other charges.

While officer was conducting stationary observation, they observed a motorcycle traveling well above the posted speed limit. As the officer got behind the subject and attempted to perform a traffic stop, the driver of the motorcycle blew through a four way stop. The officer ran the registration plate and observed that the registered owner has had incidents requiring police in the past, including a threat of violence. As the subject stopped at a light, the officer was able to positively identify that this was in fact the registered owner. As the vehicle sped off, they ran several more stop signs and began to pass vehicles, as well as make several furtive movements to the front of his waist band. The officer believed that the subject was armed and continued to drive recklessly at a high rate of speed. The subject reached their residence, and the officer observed that they had wrecked their motorcycle. The subject continued to make furtive movements to their waistband, and the officer exited his vehicle. As the officer approached the subject, they immediately threw something to the ground and started covering it up with mulch. The officer started giving loud, clear verbal commands for the subject to get on the ground. The subject was not complying to officer's commands; additional officers arrived on the scene to assist. The subject jerked their right hand away and attempted to grab the officer's arm and at this time, the officer deployed his Taser. Due to close range, the probes of the Taser only spread out a few inches and this allowed the subject to kick the initiating officer in the chest. As the officer was able to gain control of the situation, EMS was called immediately for the subject. The officer went to the area where the subject was hiding something and recovered a fully loaded revolver. As the officer was searching the subject, they recovered a small rock of crack cocaine. The subject continued to make several threats and statements to the officers on scene. EMS transported the subject to Caromont Regional, and the initiating officer rode in the back of the ambulance. The subject was discharged and charged with Flee and/or Elude Arrest with Motor Vehicle, Reckless Driving, Fail to Stop at Stop Sign, Speeding, Red Light Violation, Improper Passing, Felony Possession of Schedule II, Possession of Firearm by Felon, Carrying Concealed Gun, Communicating Threats, Obstruction of Police Officer, Assault Government Official, and Possession of Drug Paraphernalia. The suspect was issued a \$250,000 secure bond by the Magistrate.

Officers were dispatched out to a single vehicle that had struck a tree. When officer arrived on the scene, they determined that the vehicle had attempted to make a

right turn and ran off the roadway. The vehicle could not get stopped before striking a tree. The driver was found to be deceased inside the vehicle.

Officer conducted a traffic stop after observing a black sedan make a right turn and not reduce speed as well as the license plate was expired. As the officer was attempting to stop the vehicle, they noticed the driver throw a black box out of the passenger window. While approaching the vehicle, the officer gave commands for the driver to exit the vehicle. The driver refused and was seen stuffing something in between the driver's seat and the cushion; the driver was taken into custody. The officer spoke with the passenger, whom was crying and requested EMS. As additional officers arrived on the scene, the initiating officer retrieved the black box that had been thrown out the window. Inside the box, officer retrieved 77 grams of Methamphetamine and 31 grams of Heroin. Officers also retrieved baggies, torch lighters, electronic scale, and needles. The passenger was transported to Caromont Regional where an additional two bags of Methamphetamine were obtained off the subject. The driver of the vehicle was transported to the jail and went before the Magistrate and was given a 100,000.00 secured bond. Once the passenger was released from the hospital, they were transported to the jail and went before the Magistrate and was issued a \$4,000.00 secure bond.

Officer was observing routine traffic when he spotted a vehicle in his driver's side door mirror traveling at a high rate of speed. The vehicle made a rapid left turn and continued traveling at a high rate of speed. At this time, the officer immediately turned his patrol car around and headed in the direction of the vehicle. The officer could no longer see the vehicle but as he approached the intersection, he could see tail lights and based on the distance that the vehicle had already covered, he knew they must be traveling at a high rate of speed. Finally, the officer caught up with the vehicle and initiated a traffic stop. The vehicle did not stop and continued traveling above the posted speed limit, hit the brakes and made a sharp U-turn heading into the opposite direction, reaching speeds of over 100-mph. As the vehicle attempted to make another rapid turn, they ran up on the curb and struck a fire hydrant and finally came to rest there. The driver jumped out of the vehicle and took off running. The officer immediately exited his vehicle and pursued the subject on foot. As the subject was running, he slipped on his stomach. The officer jumped the fence and took the subject into custody. As the officer walked the subject back to the scene, he smelled a strong odor of alcohol coming from the subject's breath. As the initiating officer performed a routine records' check on the subject, he was advised that he did not have a valid driver's license. EMS was called to the scene to check on the subject that was now vomiting and having a hard time breathing. EMS transported the driver to Caromont Regional and an additional officer rode in the back of the ambulance with the subject. The initiating officer went back to the crash scene and saw an open container, a 25oz beer can, in the cup holder beside the driver's

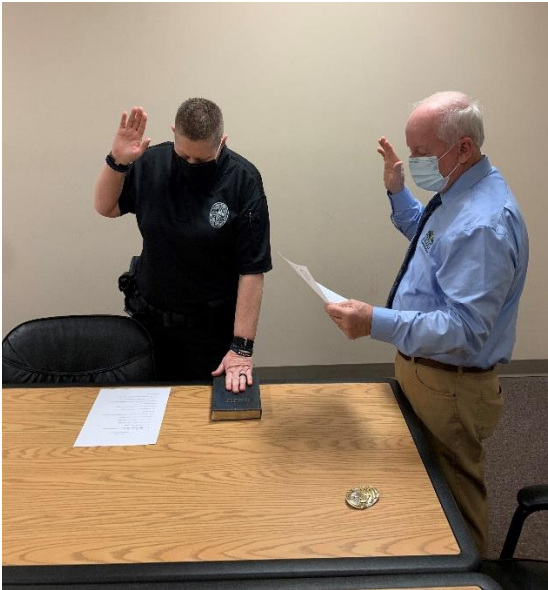
seat. The vehicle was then towed by a wrecker service, and the officer went before the Magistrate and swore out warrants for Felony Flee/Elude with Motor Vehicle, Resisting Public Officer, Possess Open Container/Consume Alcohol in Passenger Area, Driving While Impaired, No Operator's License, Reckless Driving to Endanger and Fail to Maintain Lane Control. The officer then went to the hospital to give copies of the warrants to the staff, and they advised they would contact dispatch whenever the subject was to be released.

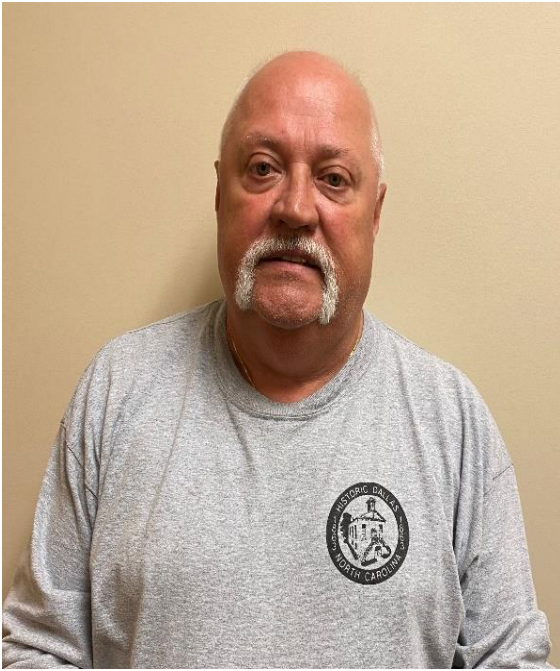
Officer responded to a drug overdose, and the subject was not breathing. Officers performed CPR until EMS arrived, and the subject was transported to the hospital by EMS.

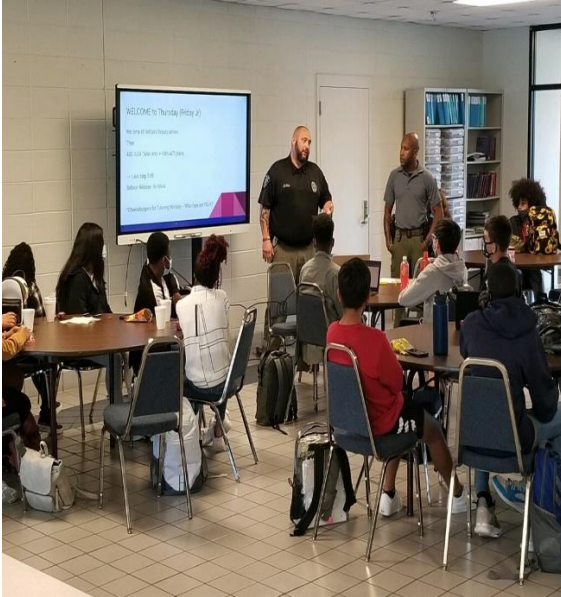


Dallas Police Department also participated in back-to-school events for Walnut Grove Baptist Church and Dallas Church of God.

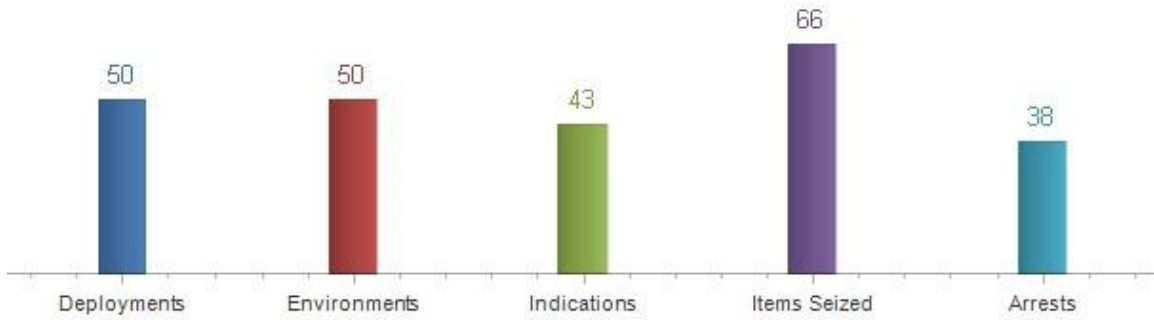

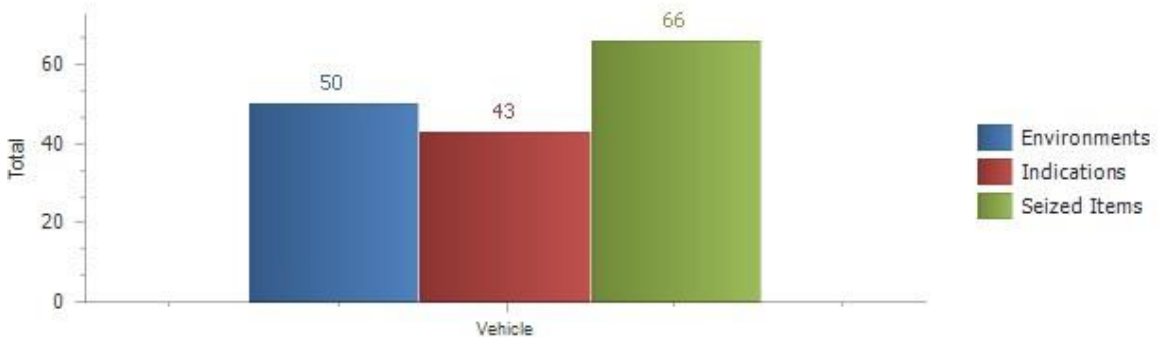

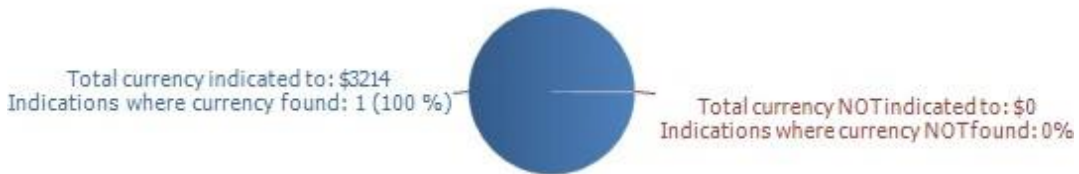

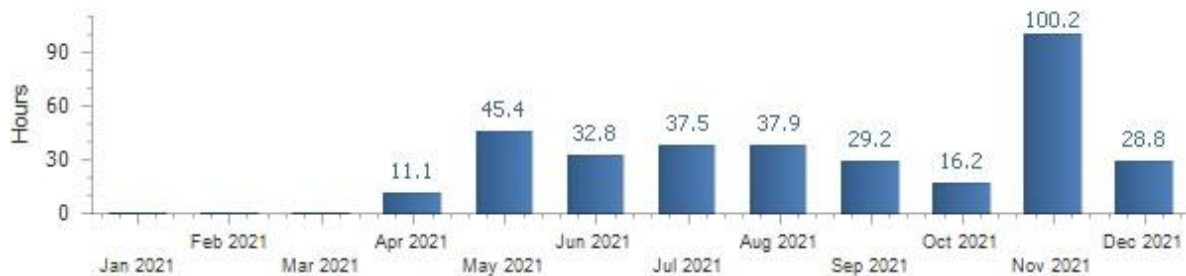
### Training By Day Of Week
