Training

Highlights, New Programs, and Certifications

The total training hours that Dallas Police Department Officers completed in the calendar year of 2024 are 3,040.5 hours. These hours are a combination of State Mandated In-Service hours, specialized schools, and safety classes. As the Town of Dallas continues to grow and the State of NC and other certified facilities offer more training, we as officers are consistently growing as well. Through this knowledge we will continue to effectively and professionally do the very best for our citizens and the Town of Dallas.

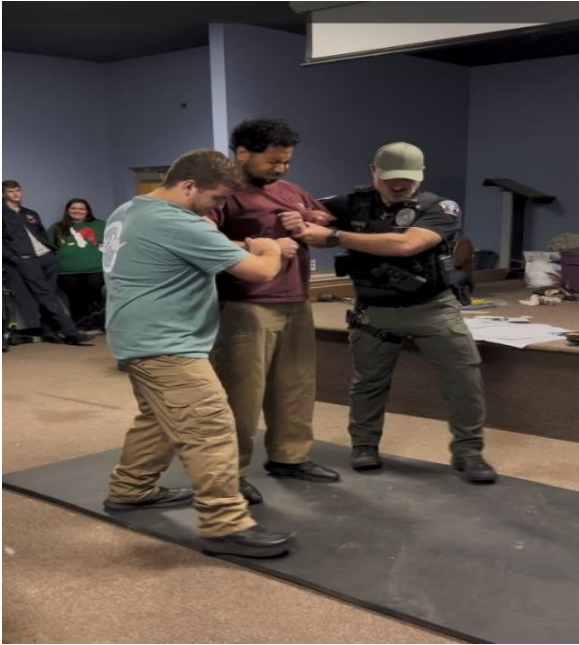
At the end of 2024 the Dallas Police Department had a staff of 14 sworn full time employees, 2 non-sworn full-time employees, 2 part-time non-sworn employee and 1 sworn reserve employee. Within the 15 sworn employees we currently have (5) that are Certified Field Training Officers, (2) that are Certified Field Training Supervisors, (4) that are Certified in Advanced Roadside Impaired Driving Enforcement, (1) that is K-9 Certified, (6) that are Radar Operator Certified, (1) that is Lidar Certified, (12) that are Certified Stop Stick Operators, (6) that are Certified in Less Lethal, (14) that

are Certified in Oleoresin Capsicum (OC) Spray, (7) that are Certified in Baton, (14) that are Taser Certified, (7) that are Intoximeter Certified, (2) that are firearm Armors, (2) that are Crisis Intervention Team Certified, (4) that are certified School Resource Officers, and (10) that are certified in Standardized Field Sobriety Testing (SFST). All sworn officers also completed training to use and operate the (7) Alco-Sensors units the department has.

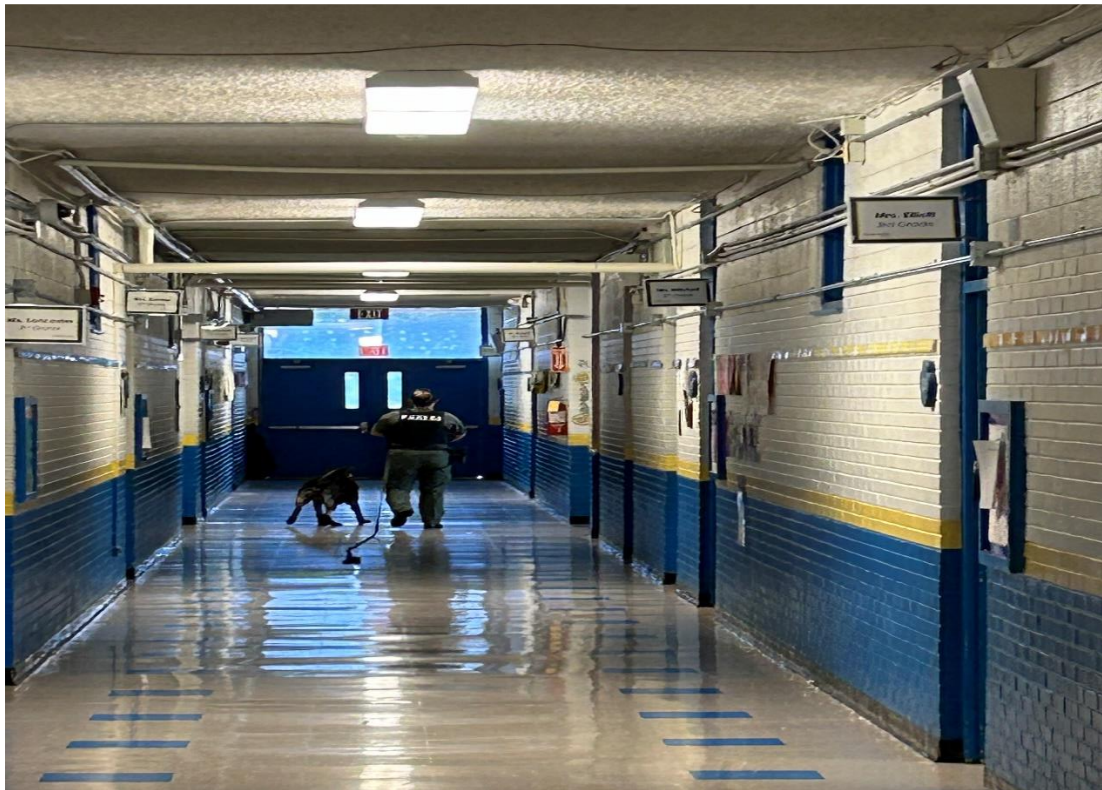

Case Review Highlights

Please note that this is a few case reviews with highlights. These are not all of the reports and or incidents reported and investigated. These highlights are cases that was released to the press and the citizens.

On January 10th, 2024 at approximately 11:24 am, officers attempted to conduct a traffic stop on a Honda Civic near the Dallas Christian Ministries on E. Trade St. The vehicle pulled into a residential driveway and the female driver jumped and ran from the scene. Officers began to pursue them on foot. A bystander flagged down other responding officers and advised the way the suspect was running. The suspect was located and taken into custody at the intersection of Byers St. and Wilkins St. The female suspect was identified. She was charged with: possessing methamphetamine, possessing heroin, possessing a Schedule II-controlled substance, possessing drug paraphernalia, resisting public officers, driving while license revoked, license plate frame/cover violation, flee/elude arrest mother vehicle, and felony to appear. She was booked into the Gaston County jail under a \$10,000 secured bond.

On February 27th, 2024 at approximately 2:43 pm, officers responded to Overland Dr. for a call that a construction worker's Chevrolet Silverado truck had been reported stolen. The suspect was described as a white male with blonde hair. Witnesses to the theft positively identified the male suspect. The vehicle was located shortly by the Gaston County Police Department on Charles Raper Jonas Hwy. in Stanley. A short vehicle pursuit was ensured. Stop sticks were deployed, and the vehicle came to a stop. Mr. Bostic was apprehended and subsequently turned over to the Dallas Police and booked into the Gaston County Jail.

On Monday, February 19th, 2024, the Dallas Police Department learned of an alleged child abuse after being called to the 2800 block of Meadow Creek Drive. On arrival, a juvenile alleged that he was attacked by his mother and suffered injuries. The Dallas Police Department immediately started investigating the possibility of child abuse. During the investigation, it was determined through physical evidence and medical examination that the juvenile suffered some form of

trauma. The investigation led to multiple warrants being obtained on the mother, of the juvenile. On March 1st, 2024, she was arrested and booked into the Gaston County Jail under a \$25,000 bond.

On March 2nd, 2024 at 10:24 pm, Dallas Police responded to the report of numerous suspicious vehicles being parked at the Ascending Faith Christian Church without permission. When officers arrived on the scene, a green Dodge Challenger began to leave the parking lot, ignoring officers' commands to stop. The vehicle fled the area at a high rate of speed without any headlights on. Dallas Police attempted to conduct a traffic stop for further investigation, but the vehicle did not stop and continued to flee. Officers lost sight of the vehicle around the Ratchford Road area. A Gaston County Police Officer observed the vehicle on Dallas-High Shoals Hwy., heading back towards Dallas. A traffic stop was conducted on the suspect vehicle in the parking lot of the Super Clean Carwash. The driver was arrested for DWI, possession of ecstasy, and numerous other charges. He was booked into the Gaston County Jail under a \$20,000 bond.

On March 28th, 2024, the Gaston County Police Special Investigations Unit (SIU), working a joint investigation with the Dallas Police Department, obtained information that two large packages containing illegal narcotics were going to be delivered to an address in Dallas. During the investigation, detectives were able to obtain a search warrant leading to the seizure of eight kilograms of cocaine. The estimated street value of the cocaine is \$570,000. As a result of the investigation, a female was arrested and charged with Trafficking by Possession of Cocaine. Officers from the GCPD Community Policing Division assisted with this operation.

On Sunday, April 28th, 2024 the Dallas Police Department responded to a shooting incident on Eastway Drive located in Spencer Mountain Village. Upon arrival, after gathering information it was determined that the shooting was a direct result of an altercation between two male individuals. On Monday, April 29th, 2024, the Dallas Police Criminal Investigation Division and patrol officers conducted further follow-up investigations into the incident. Through the investigation, it was confirmed that no individuals were shot. It was determined that a male subject did brandish a handgun during the altercation. It is not yet

determined who fired the gunshots in the neighborhood. On Monday, May 6th, 2024 the Dallas Police Department arrested the male suspect for possession of a Firearm by Felon. The male suspect was booked into the Gaston County Jail under a secured bond.

On May 25th, 2024 at 3:09 pm, Dallas Police units were dispatched to Eden Glen Drive, in reference to, a shooting. Upon the officer's arrival, a Gaston County sheriff's Deputy has two of the subjects involved at gunpoint. Those two subjects were taken into custody for questioning. It was determined that these two subjects were inside a vehicle and had exchanged gunfire with two other subjects in another vehicle. The other vehicle fled the initial shooting scene and was abandoned at the Dallas Cherryville Highway intersection. Two black males fled on foot potentially with firearms and bags. One of the suspects was located on Dallas High Shoals Highway by Gaston County Police and taken into custody. There were no injuries resulting from the shooting. On May 26th, 2024 Dallas Police arrested a male suspect in connection with the shooting. He was charged with: Attempted Murder, Discharging a Firearm into Occupied Property, and Damage to Real Property. He was booked into the Gaston County jail under a \$250,000 secured bond.

On Friday, June 28th, 2024 at approximately 04:12 am, Dallas Officers responded to a check subject call around the 900 block of Sean Michael Drive (Long Creek II Apartments). The caller reported seeing a black male walking around the parking lot of the apartment complex, using a flashlight to look in cars while pulling on the door handles. Upon the officer's arrival, they observed a male jump out of the bushes and start running through the parking lot. The male got into a vehicle and exited the parking lot at a high rate of speed. Dallas Officer began to pursue the vehicle down New Hope Road toward Gastonia. The suspect vehicle continued to travel to the area of Eastridge Mall where he crashed into a utility pole near the intersection of New Hope Road and Pearl Drive. The male suspect was taken into custody by officers. He was then transported by EMS to Caromont Reginal Medical Center for injuries sustained from the crash. He was released from the hospital shortly after and then transported to the Gaston County Jail, where he was booked and held with no bond, and was charged with: Attempted break/enter motor vehicle, Flee/elude arrest by motor vehicle, Resisting public officer along with several drug and traffic charges

On July 11th, 2024 at approximately 2:46 pm, Dallas officers responded to the report of a driver slumped over the wheel in a red Buick on S. Gaston Street near Robinson Street. Upon arrival, officers made contact with a male subject. While speaking with the male subject, it was determined he had numerous outstanding felony warrants. While Officers were placing the male subject under arrest, they observed drug paraphernalia inside the vehicle, which led to the locating of 29 grams of methamphetamine. The male subject was transported to the Gaston County Jail, where he was charged with numerous drug offenses as well as his warrants, He received a \$725,000 bond.

On July 21st, 2024 at approximately 12:49 pm, Officers of the Dallas Police Department received a call for an accident with injuries at 513 E. Main Street. While units were responding, Gaston County Communications advised that two black males were fighting inside a vehicle and one had a gun. Police officers arrived on the scene and detained two subjects. One of the subjects was detained at gunpoint due to having a handgun in his hand. He complied with officers' commands and was taken into custody without incident. A subsequent investigation revealed that the male suspect went to the residence of the victim to buy shirts. The suspect then pulled out a gun and attempted to rob the victim. The victim dove into the offender's vehicle and wrestled him for the firearm. The vehicle was knocked out of gear during the scuffle and rolled down a hill colliding into a residence. Marijuana and paraphernalia were located inside of the suspect's vehicle during a vehicle search. The suspect was placed under arrest for armed robbery, assault by pointing a gun, simple possession of marijuana, and possession of marijuana paraphernalia. He was transported to Caromont Reginal Medical Center and evaluated before being booked into the Gaston County Jail where he received a \$250,000 secured bond.

On September 9th, 2024 at approximately 6:44 pm, Dallas Officers responded to the Walmart Marketplace on Dallas Cherryville Hwy. in reference to an irate and possibly impaired subject, inside of the restroom. Officers made contact with the female subject outside of the restroom. After investigating the complaint, a large quantity of narcotics was located on the subject. The female subject was placed under arrest and charged with: Trafficking heroin, Possession of schedule II-controlled substance with intent to manufacture/sell/deliver, and Resist public officer. She was booked into the Gaston County Jail under a \$250,000 bond.

Informational News

Dallas Police Department hired several new employees in 2024. Christopher Mulkern, Paul Buelin, and Stephanie Garcia, were all hired and sworn-in as full-time patrol officers. Officer Garcia had one year to complete her North Carolina training in BLET after coming to the Dallas Police Department from a Florida agency. Gavin Jenkins and Ashton Ward were both hired as full-time employees of the Dallas Police Department and sent to BLET at Gaston College. After graduating from BLET both were then sworn in as full-time patrol officers. Nathan Anderson was also hired as the new part-time records clerk. The Dallas Police Department also had a promotion, Logan Hamby was promoted to K9 Supervisor and got a new K-9 partner, K-9 Salko. Several Officers achieved their Intermediate Certificate. This certificate is earned through attending hundreds of hours of training and education. Officers earning their Intermediate Certificates are Logan Hamby, Nathan Potter, and Brett Campa. Sergeant Bradley Beer also earned his Advanced Certificate. This Certificate is earned by hundreds of hours of training, continued education, and many years of service. Dallas Police Department is proud to announce all the new hires and also proud to congratulate all the officers on their promotions and achievements.



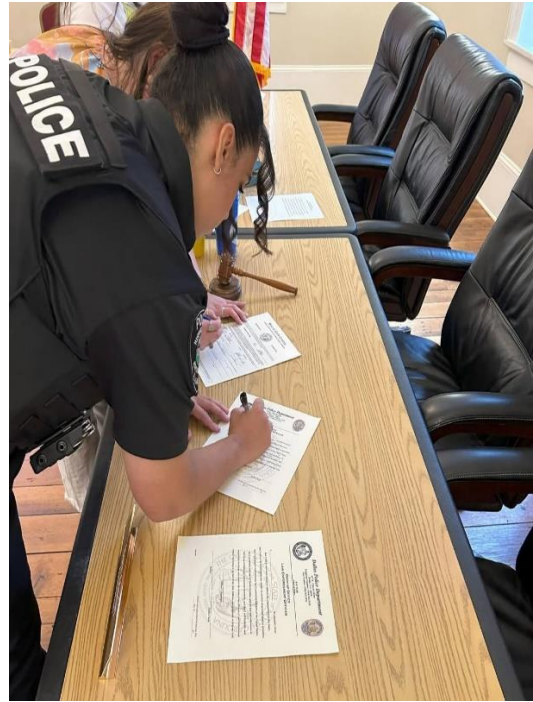

Dallas Police Department applied for a grant through the Governors Crime Commission. The department received grant funding of \$23,006.02 to buy 14 Bolawraps, 14 Bolawrap holsters, and 90 cartridges. Bolawraps are a handheld non-lethal device used by law enforcement to remotely restrain individuals by deploying a Kevlar cord that wraps around their legs or arms, allowing officers to safely detain someone from a distance, particularly in situations where de-escalation is needed.









Community Policing and Events

Events and Community policing is important to the officers of the Dallas Police Department in hopes that it will increase trust and cohesion between the police and the community.

The Dallas Police Department partnered with several local businesses and sponsors nearby and raised money for Christmas with a Cop. Donations collected were used to supply Christmas for a few carefully chosen families, pay several utility bills for people in need, and hand out gift cards to random strangers in town.

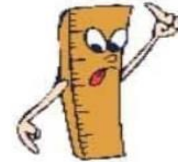


Dallas Police Department came together with Carr Elementary School and set up a pumpkin patch for the kindergarten students. The kids enjoy getting their very own pumpkins.

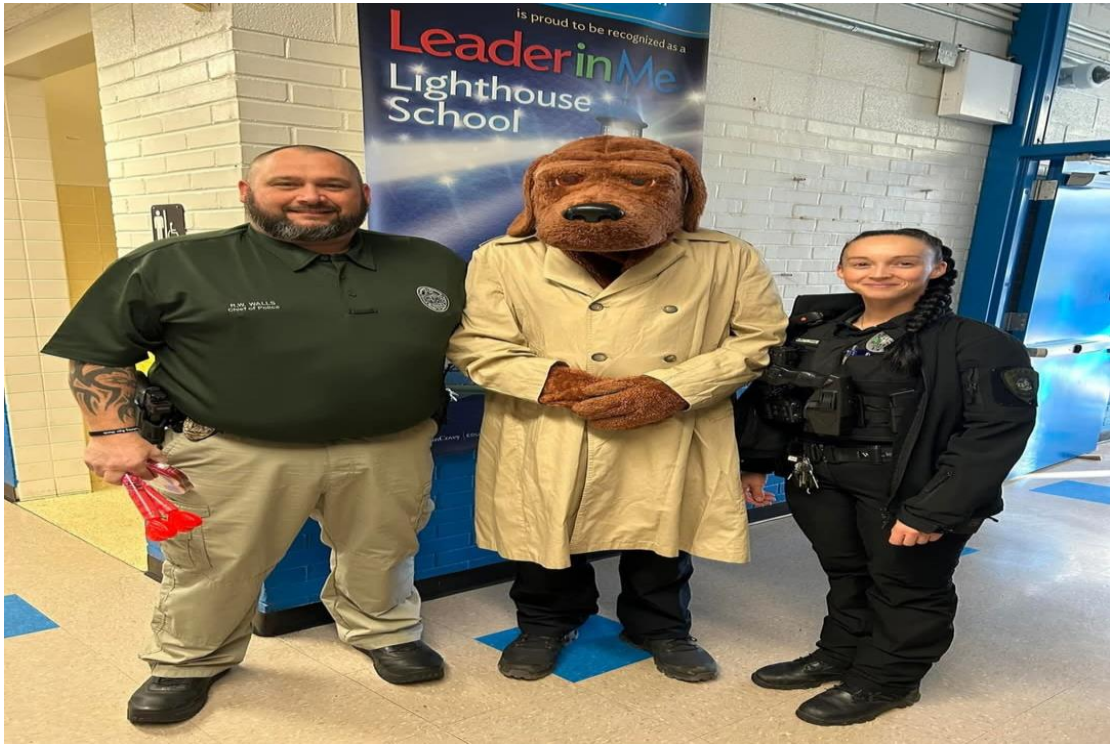
Dallas Police Department organized the NOGA Senior Parade on the first day of school

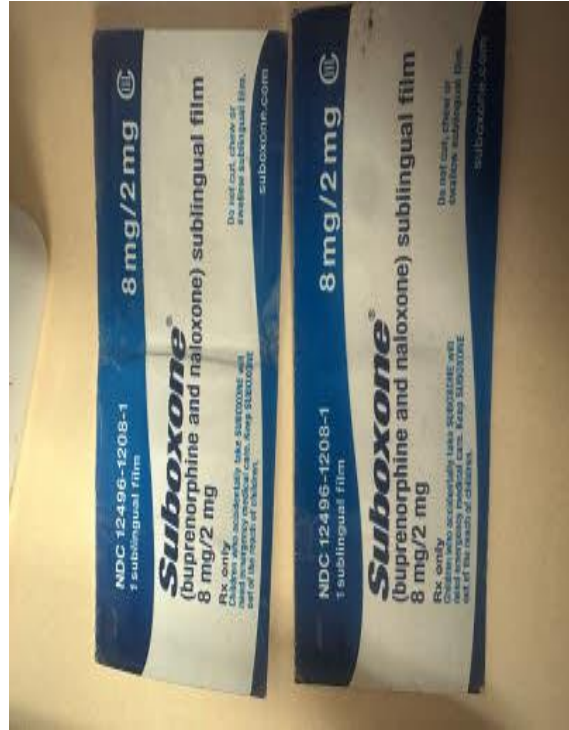

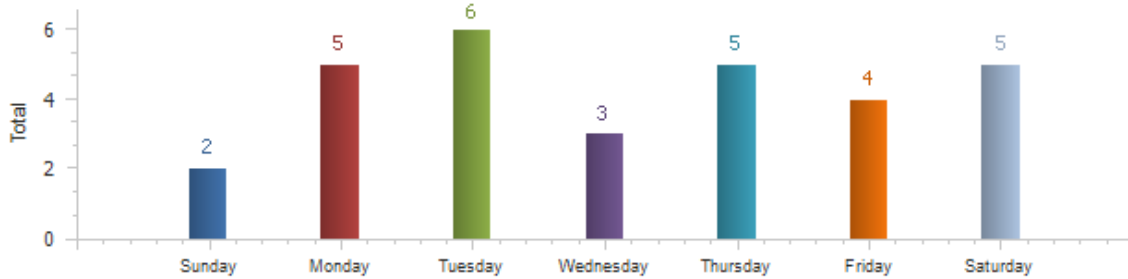

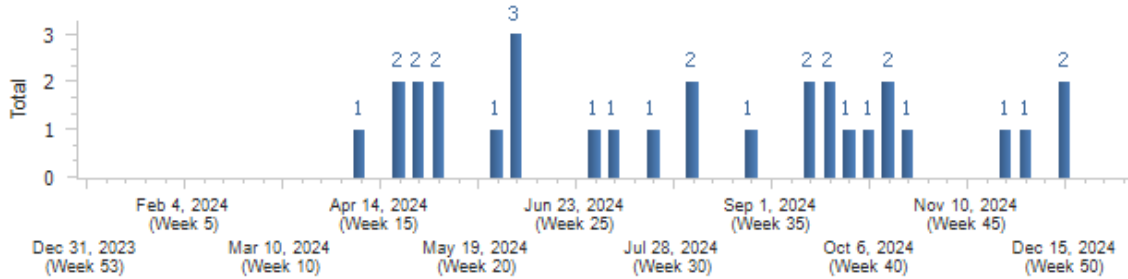

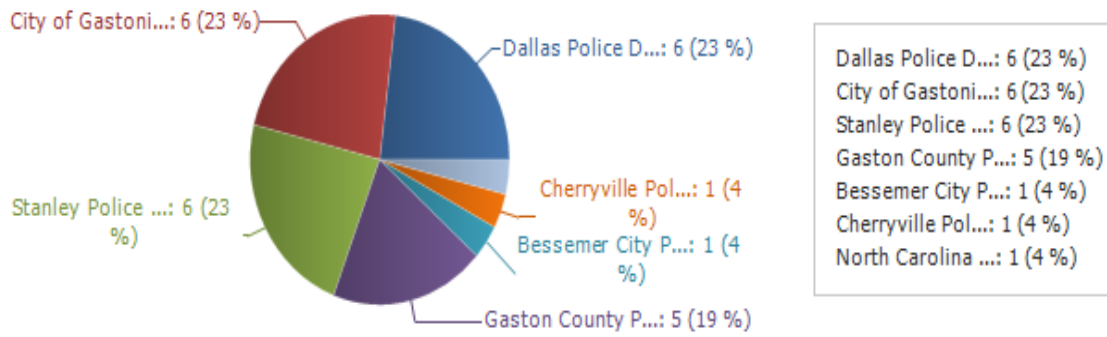

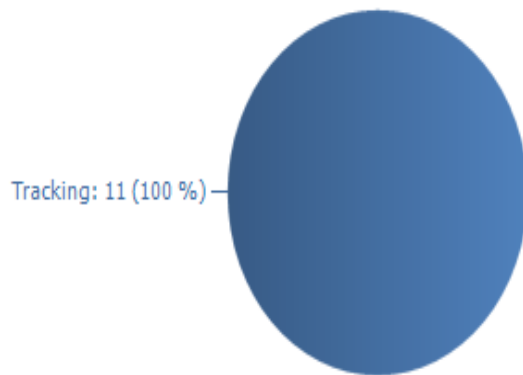

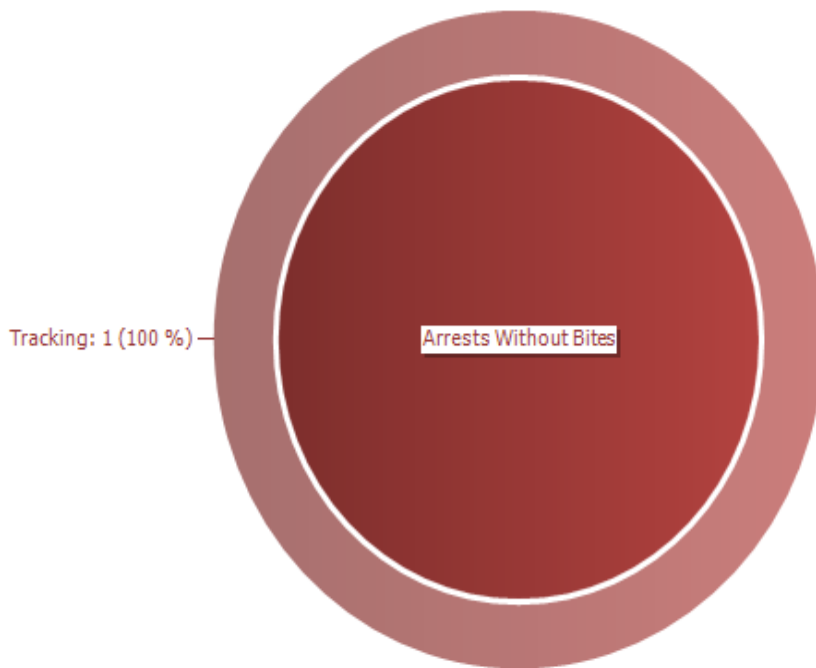


Patrol Types

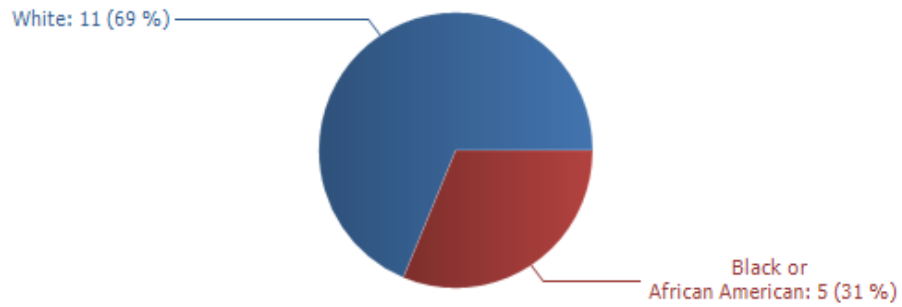

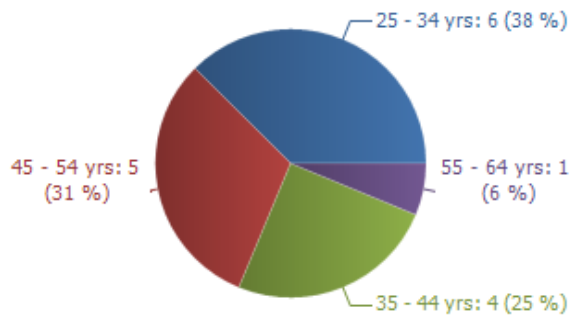

Arrests by Race/Ethnicity

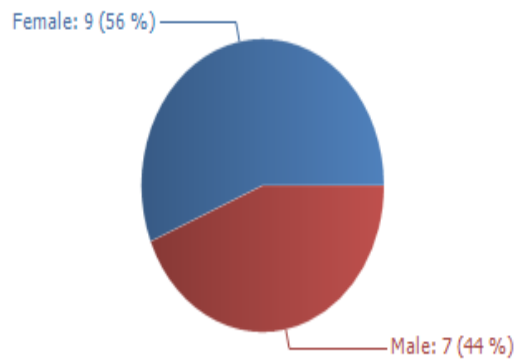

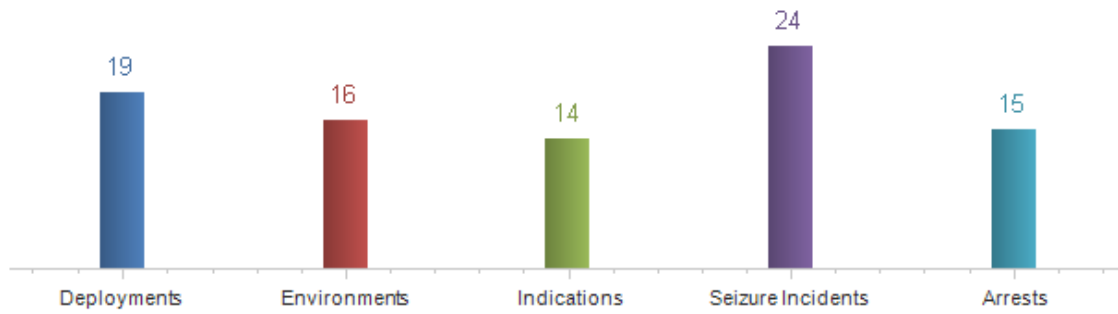
Arrests by Age



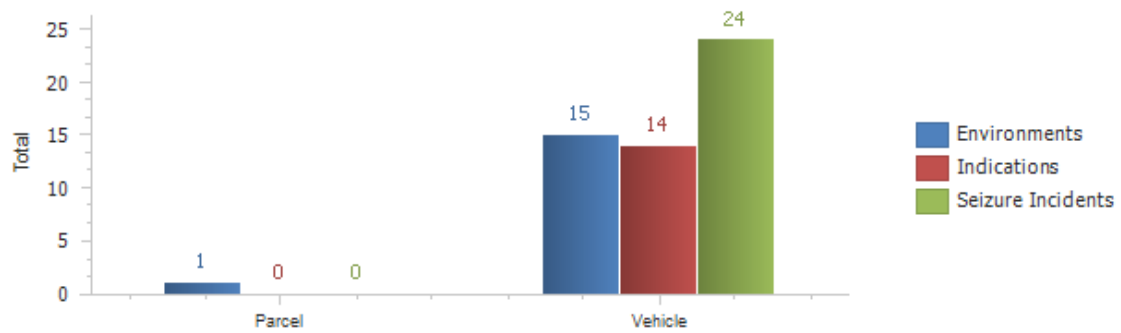
Arrests by Sex At Birth
